## Portfolio Distribution

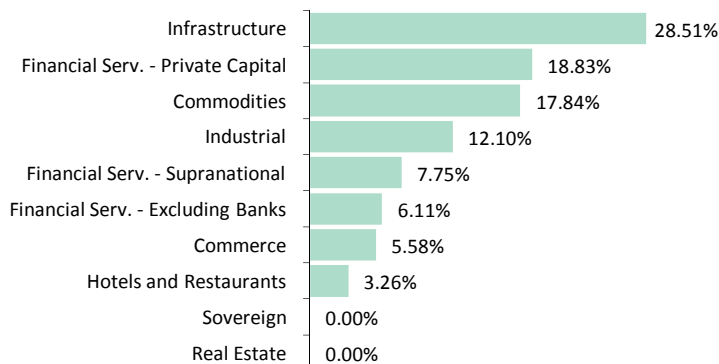
### By Asset Type:



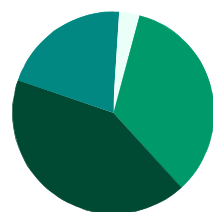
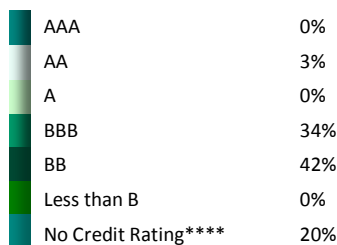
