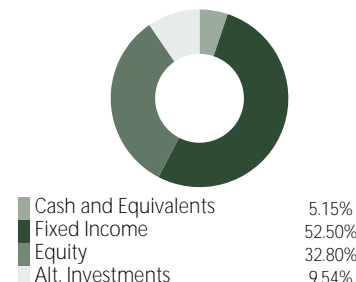

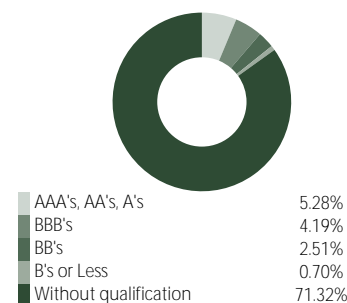

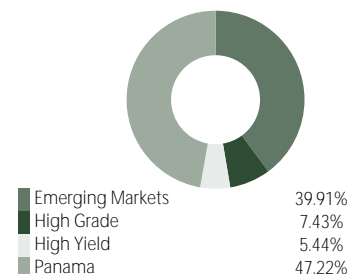

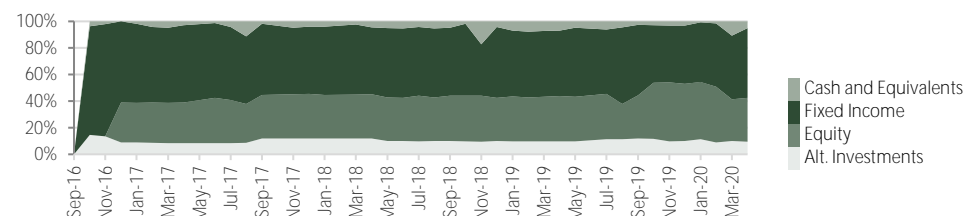

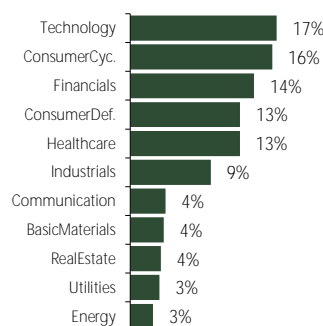

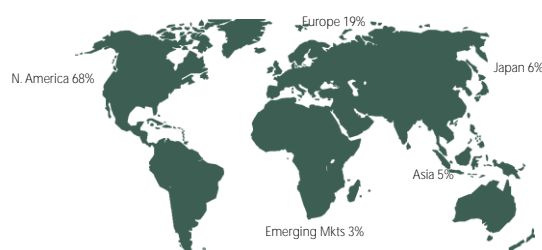
Historical Asset Allocation
