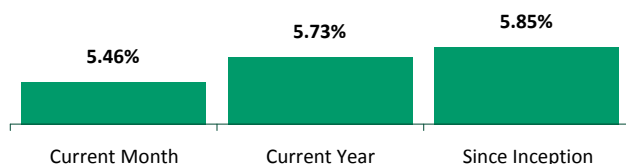

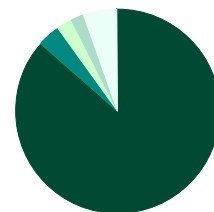

## Portfolio Distribution

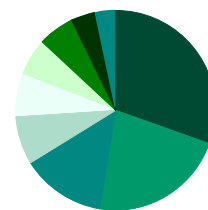

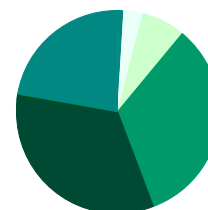
