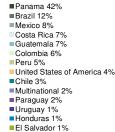


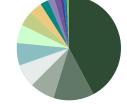
Asset Type Allocation

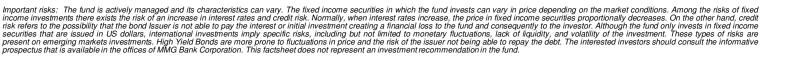
