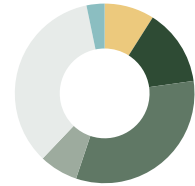

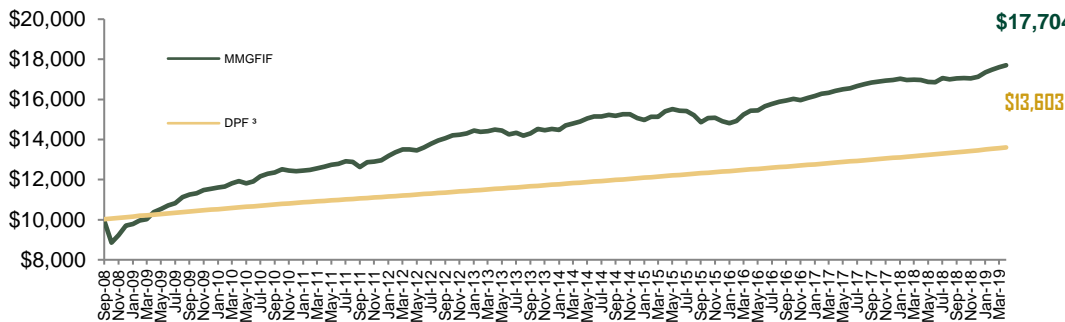

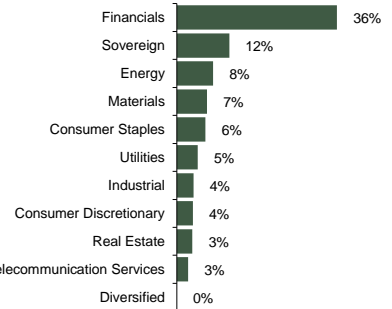

Industry Allocation

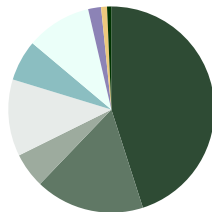

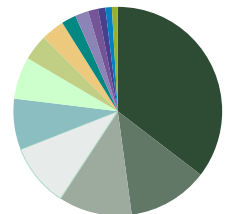
