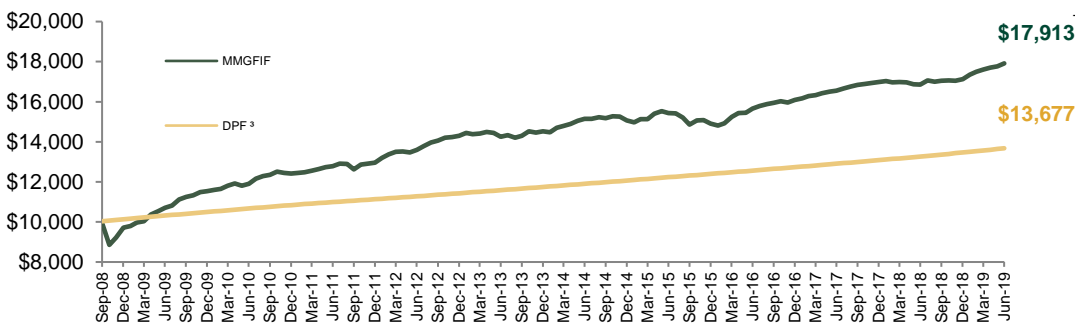

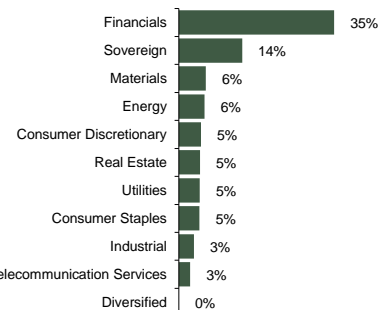

Industry Allocation

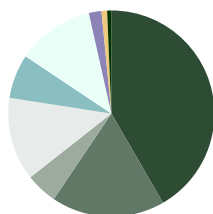

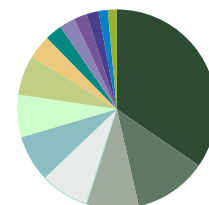
